



INSTRUCTIONS FOR LOGGING INTO A LIVE CLASS SESSION

We recommend using a **desktop or laptop computer**, since some of the functionality described in this document may be unavailable in certain mobile devices.

BEFORE CLASS DATE (Recommended)

To ensure a seamless sign-on process for the class, we recommend checking a few things before the day of the class:

1. Confirm you can log into your Learning Portal account

You may have registered yourself online for the class, or staff will have asked you to create an account for the Learning Portal (through TalentLMS). Please be sure that you are able to access your account here:

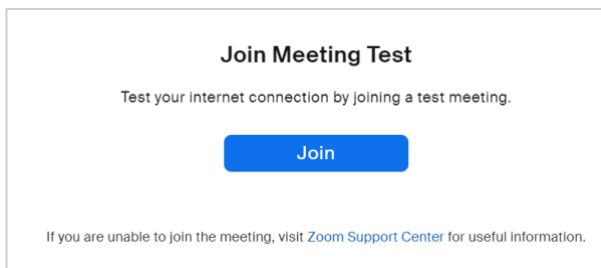

2. Test your device’s capabilities for Zoom

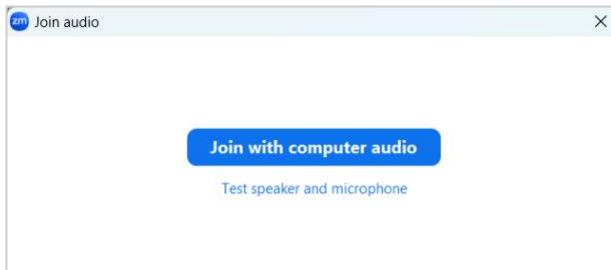

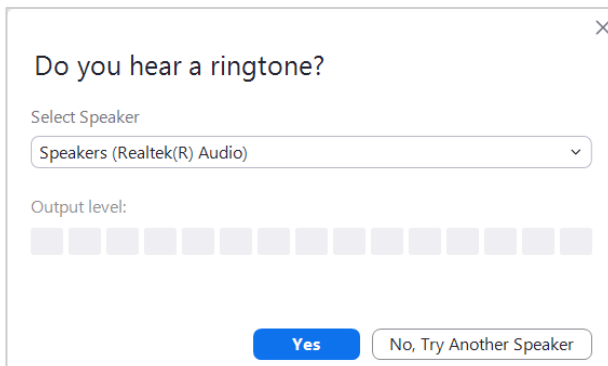
Join Meeting Test (you can either join from your browser or download the Zoom app).

You will not be required to use a camera or microphone for the course, but please be sure that your **speakers** detect the test sound:



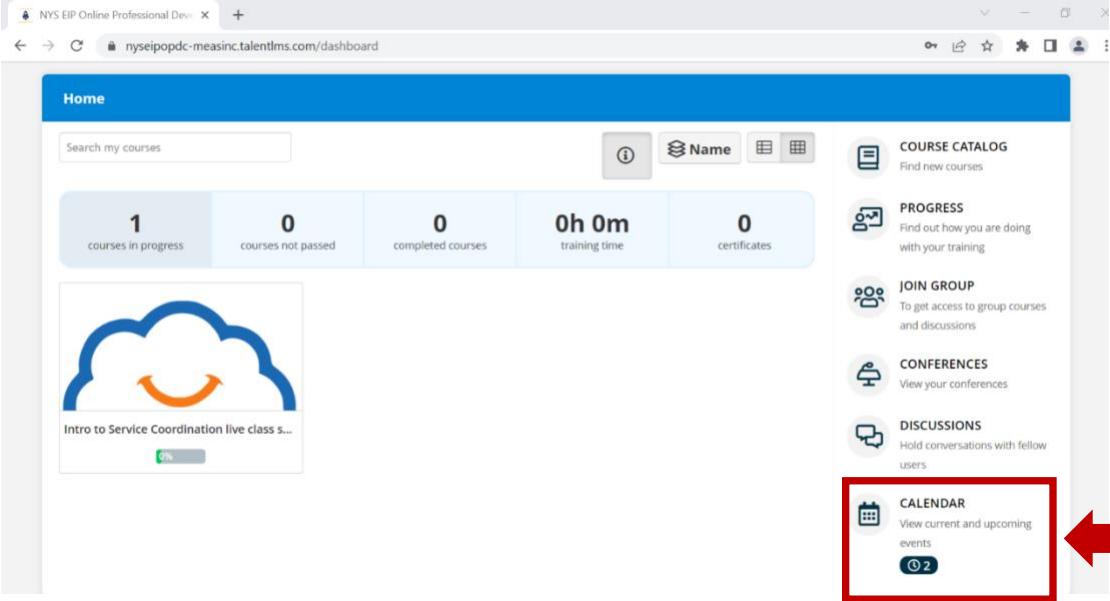


DAY OF CLASS

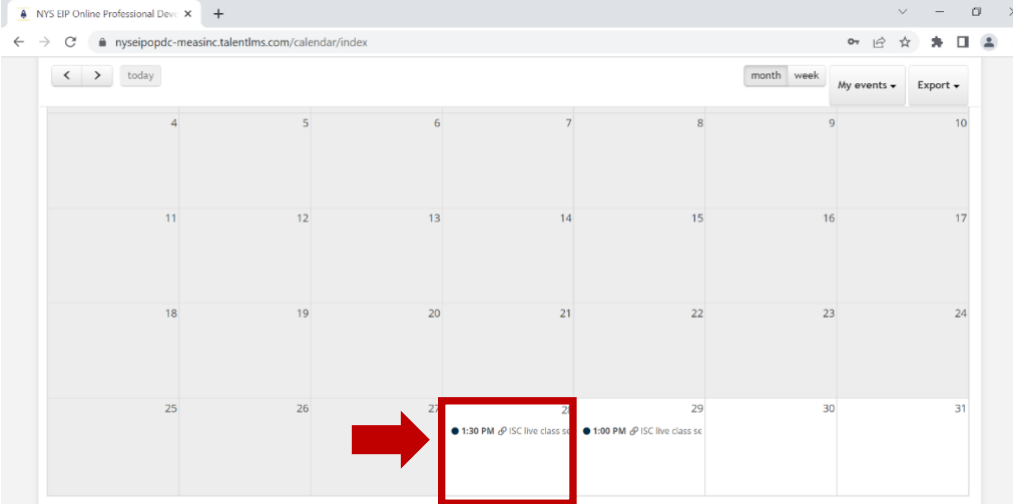
1. 10-15 minutes before the start of the session:

Log into your account at <https://nyseipopdc-measinc.talentlms.com/>

2. Click on the Calendar (shown below).

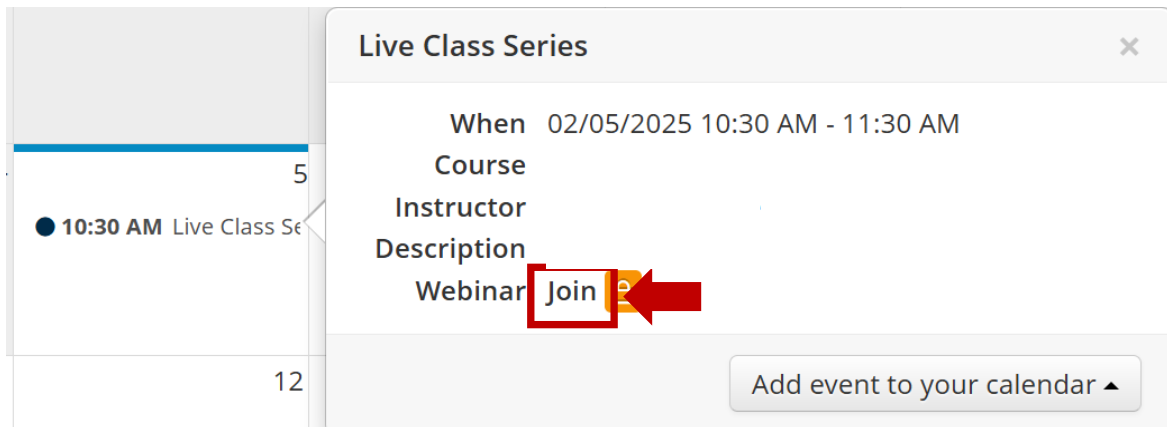


3. Click on the session you wish to join (example below).



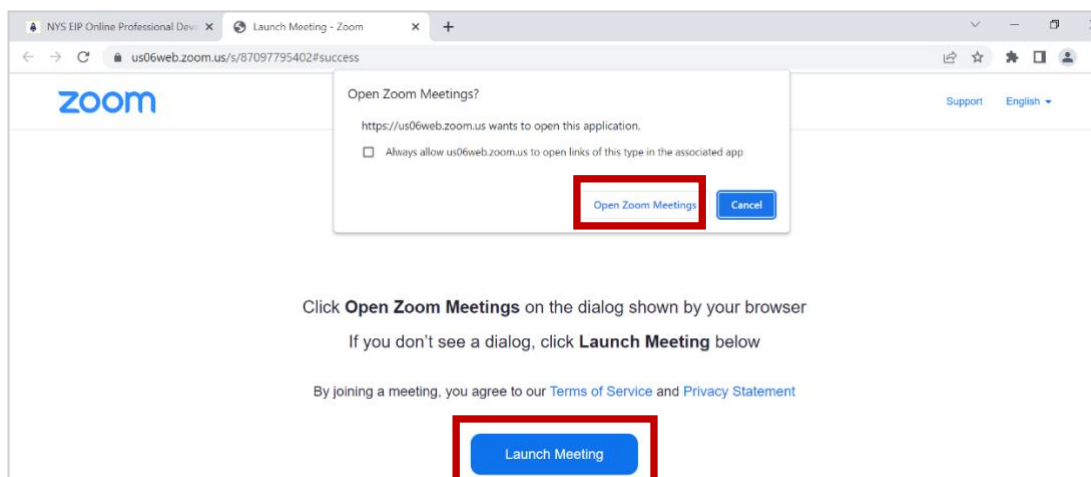


4. Click “Join.”



Note: The “Join” functionality will not be active until 15 minutes prior to the session start time. It will appear as grayed out until that time. If, for some reason, it does not activate within 15 minutes of the session start time, try refreshing/reloading your browser or logging out and logging back into your TalentLMS account.

5. If you already have the Zoom app, you may be prompted to “**Open Zoom Meetings**” (as shown below), or you can **Launch Meeting** in your browser.





6. If prompted, enter your first and last name in “Your Name,” then Join Meeting.

If you are not prompted for your name, you can add it once you are in the meeting.

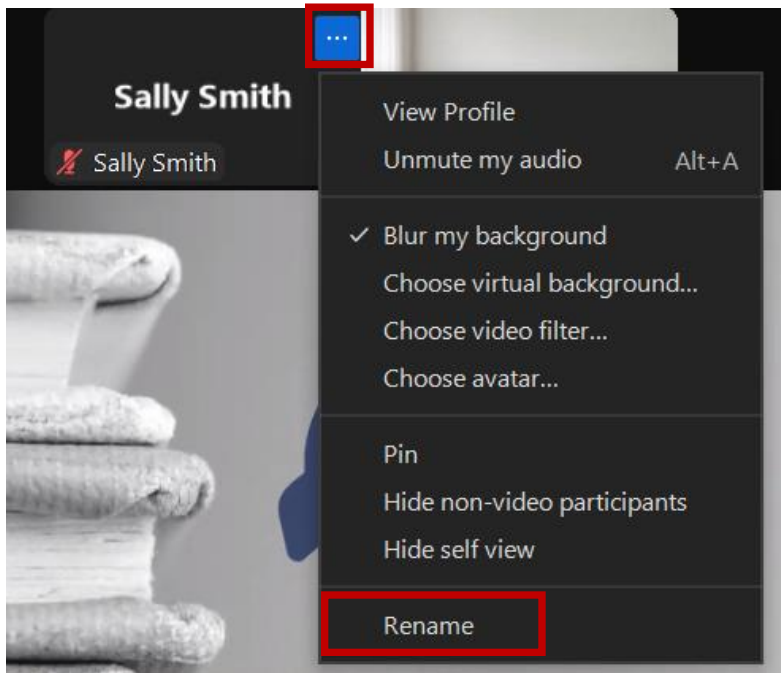

- If the **name** on the Zoom account you are using is different from the one you used when registering for the course, please update the Zoom name so the meeting host can verify your registration. You can rename yourself by selecting the menu at the top right of your name then selecting “Rename.” The host can assist you as needed.



- Your microphone will be automatically **muted** upon entry to the session. Please keep your microphone muted for the duration of the session to minimize background noise. You may use the **chat** feature to communicate with the instructors as needed.
- **You must participate in the entire session from start to finish. If you log in late, you may not be admitted into the session. If you log out early, your participation will not count, and you will not be eligible to receive a certificate of completion for the live course.** In such cases, you may enroll in and complete the self-paced version of the course to receive a certificate of completion. If the class is presented in multiple sessions, you must be present for all sessions.


AFTER THE FINAL SESSION / COURSE MATERIALS

If you were present for all required class sessions, you will be asked to complete a post-course survey. Upon completion of the survey, you will be issued a certificate of completion. If for some reason you are not eligible to receive a certificate (for example, if you already took the same course recently), you will be notified. The survey will only be available after completion of the live session/s.
